Dear Sir/Madam,

we wish to inform you that Regulation (EU) no. 679/2016 "General Data Protection Regulation" provides for the protection of persons with regard to the processing of personal data. In accordance with the aforementioned legislation, such processing will be based on the principles of lawfulness, fairness and transparency, appropriateness, relevance and restriction, accuracy and updating, non-excessiveness and accountability. We therefore provide you with the following information:

- The data you provide will be processed for the following purposes: solely for the purpose of activating an alias career as a protective measure for persons who need to adopt a name other than their registered name within the University.
- Personal data will be processed by automated and manual means, and data will be stored and erased in accordance with legal requirements.
- The provision of data is compulsory and any refusal to provide such data will make it impossible to activate the Alias Identity.
- The data will not be disclosed to other parties and will not be disseminated.
- The controller is Vita-Salute San Raffaele University with registered office in Milan, Via Olgettina 58, duly represented by the Managing Director.
- The persons authorised to process the Applicant's data are: the Rector, the Managing Director and the Contact Person, as identified in the confidentiality agreement, in order to manage the Alias Identity of the data subject.
- The University has appointed GSD SISTEMI E SERVIZI S.C.A.R.L. as its data protection officer. The professional nominated by GSD to serve as DPO is Gabriele Tettamanti.
