## CALL FOR CREDIT EVALUATION TO TRANSFER BEYOND FIRST YEAR

*This is a translation of the articles listed in the Chancellor's Decree n. 9004 originally in Italian language. It is only meant for information purposes and does not have any legal value.*

### Art.1 Available places

The places available for admission to restricted access degree programs of the Vita-Salute San Raffaele University are those vacant following withdrawal and transfer requests to another degree program or University.

The provisional number of places available at the date of issue of this Call is indicated in the following table:

Please note that the number of places available may be increased due to further withdrawals and/or outgoing transfers. A notice will be published in the Resolution of the Faculty of September 2025.

### Art. 2. Transfer application requirements

For admission to restricted access degree programs (Law 264/1999), candidates can apply for transferring after first year according to the procedure attached to this Call and published on the UniSR website.

**Enrolment after first year, following the credit recognition procedure of the University, can only take place within the limit of available places.**

### **Art. 3. How to submit application**

The procedure to submit application for transfer credit evaluation is provided both in this Call and on the UniSR website.

Applications must be submitted online **starting from 1 July 2025 at 12:00 p.m. and by 25 July 2025 at 12:00 p.m. (Italian time).**

Registration for the transfer credit evaluation must be completed exclusively online through the University website: <https://univr.esse3.cineca.it/Root.do>.

**Incomplete applications and/or applications submitted after the deadline will not be considered.**

### **Art. 4. Evaluation**

The applications received will be evaluated by the Academic Committee which will determine the eligibility of the candidate on the basis of the exams taken and their compatibility with the UniSR study plans. The Academic Committee will also establish the year of enrolment.

If a number of students exceeding the available places is admissible, a ranking list will be drawn up on the basis of the criteria established by the Council of the Faculty of Medicine and Surgery. In case two or more candidates obtain the same score, the younger student will precede.

The Academic Committee will not consider applications if the number of recognized exams were not sufficient to enrol after first year. All requirements must be met to enrol.

Any ranking lists, with reference to the information mentioned above, will be published at the end of the evaluation procedure and in any case no later than 25 September 2025. As the applications results are published, information for the enrolment to the a.y. 2025/2026 will be provided.

### **Art. 5. Miscellaneous**

The person in charge of this procedure is the President of the Academic Committee who presides over the evaluation of the applications.
