RECTOR'S DECREE NO. 9408

Selection procedure for the recruitment of 1 Researcher on a fixed-term contract, pursuant to Article 24(3) a) of Italian Law 240/2010 as per Annex no. 1

Having regard to Decree No. 660 of 31 August 1945, as amended by Italian Law No. 106 of 15 April 2004;

Having regard to Italian Presidential Decree No. 445 of 28 December 2000, laying down the Consolidation Law incorporating legislation and regulations on administrative documentation, as amended;

Having regard to Italian Legislative Decree No. 196 of 30 June 2003 on the protection of natural persons and other subjects with regard to the processing of personal data;

Having regard to Rector's Decree No. 8767 of 15 February 2024 by which the Regulations governing the recruitment of researchers on fixed-term contracts, pursuant to Article 24 of Italian Law No. 240/2010 (in the wording in force until 29 June 2022, which preceded the entry into force of Law No. 79/2022, converting Decree-Law No. 36/2022) were issued;

Having regard to the Ministerial Decree No. 639 of 2nd of May 2024 containing the "Determination of the scientific-disciplinary groups and the related declarations, as well as the rationalization and updating of the scientific-disciplinary sectors and the attribution of the latter to the scientific-disciplinary groups, pursuant to art. 15, of law 30 December 2010 No. 240";

Having regard to the Resolution issued by the Council of the Faculty of Medicine and Surgery on 19 February 2025;

Having regard to the resolution of the Board of Directors of 19 February 2025.

HEREBY DECREES

ART. 1

Selection procedures and purpose of the contract

Pursuant to Article 24(3) a) of Italian Law 240/2010, a selection procedure is hereby announced for the award of 1 Researcher with fixed-term contracts (referred to as a "**Junior contract**"), as provided for in Annex no. 1, which forms an integral part of this call for applications.

The purpose of the contracts is to carry out research, teaching, integrative teaching and student service activities at the Faculty of Medicine and Surgery of Vita-Salute S. Raffaele University of Milan.

ART. 2

Requirements for participation in the selection procedure

Italian and foreign candidates who meet one of the following requirements **may participate** in the selection procedure:

a) PhD or **equivalent qualification** obtained in Italy or abroad

or

b) medical residency diploma.

In the case of a PhD obtained abroad, the candidate must submit documentation demonstrating equivalence (pursuant to Article 74 of Italian Presidential Decree no. 382/1980) or the act of recognition of the qualification for the purposes of participation in the selection procedure pursuant to and for the purposes of Italian Legislative Decree 206/2007, as amended by Legislative Decree 15/2016 (for EU qualifications), and Article 49 of Italian Presidential Decree 394/1999 (for non-EU qualifications), issued by the competent authorities, in accordance with the regulations in force.

In order to ensure the widest possible participation in the procedure, the documentation demonstrating the recognition of the qualification must in any case, under penalty of exclusion, be submitted to the administration department at the time of any recruitment.

The following are **not eligible for participation** in the selection procedure:

- full and associate professors and researchers already hired on a permanent basis, even if no longer in service;
- those who have had contracts as research grant holders and researchers on fixed-term contracts, in accordance with Articles 22 and 24 of Law 240/2010, respectively, at Vita-Salute S. Raffaele University or at other Italian state, private or virtual Universities, or at the Institutions referred to in Article 22(1) of Italian Law 240/2010 for a period that, when added to the duration of the contract referred to in this call for applications, exceeds a total of twelve years, even if not continuous. Periods spent on maternity leave or leave for health reasons in accordance with the legislation in force do not count for the purposes of the duration of these relationships.

Moreover, the following may not participate in the selection procedure:

- 1) those who are excluded from the enjoyment of civil and political rights, or are the subject of a criminal conviction entailing disqualification from public office;
- 2) those who have been dismissed or discharged from their employment with a Public Administration for persistent inadequate performance or have been dismissed pursuant to current legislation;
- 3) those who have been declared disqualified for having obtained the appointment or employment by producing false documents or documents affected by irremediable invalidity;
- 4) those who are related by birth or marriage, up to and including the fourth degree, with a Professor belonging to the Faculty issuing the call or with the Rector, the Director General or a member of the Board of Directors of the University.

Both the requirements for admission and the absence of any impediment must be met on the date of the deadline for submitting applications.

Candidates shall undertake to give notification of any changes that may occur with regard to the fulfilment of the requirements for participation in the procedure.

This Administration guarantees equality and equal opportunities between men and women for access to employment and treatment at work.

ART. 3

Application submission

Applications to take part in the selection procedure, as well as the qualifications, documentation and publications considered useful for the procedure, must be submitted, **under penalty of exclusion**, electronically, using the dedicated computer-based application, on the following page of the University website:

The computer-based application requires the possession of an e-mail address in order to register with the system. The applicant must enter all the data required to generate the application and attach the documentation as PDF files. Each annex to the application (publications/documentation/etc.) shall not exceed 30 megabytes.

Up to the application deadline, the system allows users to save their application in draft mode. The date on which the application for participation in the selection procedure is uploaded is certified by the electronic system by means of a receipt that will be sent automatically by e-mail. Upon expiry of the deadline for submission, the system will no longer permit users to log in and upload documentation. Each application shall be assigned an ID number that, together with the selection procedure code indicated in the electronic application, must be specified in any subsequent correspondence.

The online application and submission procedure must be completed no later than 30 days after the publication of the call for applications in the Official Gazette. If the deadline falls on a public holiday it shall be postponed to the next working day.

The application form must be completed in its entirety, as indicated in the online procedure.

The submission of the participation application shall be carried out and completed by:

Signing the document using the ConFirma server

In order to sign the document digitally, candidates must be in possession of a hardware device (e.g. smartcard or USB device with digital signature certificate issued by an accredited Certifying Body) that is compatible with the ConFirma service. Once the signature has been applied, it will be possible to download the signed PDF.

Signing the document digitally using a personal device

In order to sign the document digitally, candidates must be in possession of a hardware device (e.g. smartcard or USB device with digital signature certificate issued by an accredited Certifying Body) and digital signature software with which to generate, using the PDF file of the document downloaded from this website, the signed file in pdf.p7m format, to be reuploaded to the website.

If one of the above options cannot be used, the document must be signed manually

In order to sign the document manually, candidates must download the PDF version of the document to their computer, print it out, sign it manually, scan it to generate a PDF file and upload the resulting file to the website.

Applications that are not signed by the candidate and/or are not accompanied by a valid ID document shall not be considered.

In the event of **proven** technical impossibility, the Administration reserves the right to accept applications for admission and the relative documentation requested in the call for applications **also in paper format** (as per the facsimile annexed to this call for applications), in compliance with the terms and conditions set out in this call for applications, observing the procedures described below:



- the participation documentation must be placed in a single, closed and sealed package containing three envelopes marked as follows: "A) Application for participation", "B) Curriculum vitae, qualifications, list of publications", "C) Publications", in accordance with the provisions set out below;
- both the package and the envelopes must bear on the outside, under penalty of exclusion, 1) the wording "selection procedure for the recruitment of 1 Researcher on a fixed-term contract, pursuant to Article 24(3) a), of Italian Law 240/2010", 2) the initials and the title of the scientific disciplinary group, 3) the profile, the Faculty the procedure refers to and the position, where applicable, as specified in the annex to the call for applications relating to the selection procedure in which the candidate intends to participate, 4) the surname, first name and address of the candidate;
- delivery may take place by either of the following options:
 - by hand, to the General and Legal Affairs Department of Vita-Salute S. Raffaele University, Via Olgettina 58, Milan, having made an appointment by telephone (tel. 0291751584-628-722-511), from Monday to Friday from 9.30 a.m. to 2.00 p.m. (closing days: Saturdays, Sundays and public holidays);
 - by registered letter with return receipt, addressed to the Rector of Vita-Salute S. Raffaele University, Via Olgettina 58, 20132 Milan; the postmark and date of the accepting post office shall be valid for deadline purposes.

Without prejudice to the above-mentioned case of technical impossibility, please note that the Recruitment Committee will assess the documentation on qualifications, publications and CVs uploaded to the PICA platform.

Qualifications, where indicated in the CV, must be duly described (relevant period, institution where the activity was carried out, description of the activity, etc.).

It should also be noted that for the application sectors in which their use is established at international level, candidates must include in their application form the bibliometric indicators (total number of citations, total impact factor, Hirsch index or similar) relating both to their own scientific production and to the publications submitted by the candidate for evaluation, using scientific databases, as better specified in Article 4 of this call for applications.

Pursuant to Italian Presidential Decree No. 445/2000 as amended by Italian Law No. 183/2011: "Certifications issued by the public administration concerning states, personal qualities and facts are valid and usable only in relations between private individuals. In dealings with public administration bodies and public service providers, certificates and sworn statements are always replaced by the declarations referred to in Articles 46 and 47". The University can therefore no longer request or accept certificates issued by public administrations or public service providers.

Applicants who are non-Italian nationals must submit their applications in accordance with the procedures and deadlines set out in this provision, without prejudice to the provisions of Article 2 above.

It is understood that declarations made within the application for participation are considered to have been issued pursuant to Italian Presidential Decree no. 445 of 28 December 2000 as amended, only for candidates entitled to use the forms of simplified certification for bureaucratic purposes permitted by the said Decree.

Foreign candidates not entitled to use the forms of simplified certification for bureaucratic purposes permitted by Italian Presidential Decree no. 445/2000, may use the online procedure to upload PDF files of the qualifications and certificates issued by the competent authorities of a foreign country, accompanied

by an Italian translation authenticated by the Italian consular authority confirming conformity to the original. The originals of these documents must be presented to the Administration at the time of any recruitment.

Certificates or attestations in languages other than Italian, French, English, German and Spanish must be accompanied, on pain of their non-evaluation, by an Italian translation, certified as conforming to the foreign text, drawn up by the competent diplomatic or consular authority or by an official translator.

Applications for participation, qualifications, documents and publications sent after the deadline laid down in this call for applications will not be taken into consideration.

The Administration reserves the right to carry out appropriate checks, including on a spot-check basis, regarding the truthfulness of the content of the declarations in lieu.

Reference may not be made to documents submitted to this or other administrations, or to documents attached to the application for participation in another selection procedure.

ART. 4

Application content

The following must be stated in the application:

- 1) surname and first name;
- 2) tax code (*Italian citizen(s) or non-Italian citizen(s) in possession of a tax code issued by the competent Italian authority*);
- 3) place and date of birth;
- 4) place of residence;
- 5) nationality;
- 6) the selection procedure in which the applicant intends to participate, specifying the Faculty, the type of contract (letter a), the application scientific-disciplinary group and the scientific disciplinary sector, as well as the optional indication of "POSITION 1", "POSITION 2" as explained in the annex to the call for applications of the selection procedure in which the candidate intends to participate;
- 7) that the applicant meets the requirements for participation in the selection procedure as provided for in Article 2 of this call for applications, namely:

is in possession of an act of recognition or equivalence of a PhD awarded abroad, or that the act of recognition of the PhD awarded abroad will be presented by the deadline stipulated in the call for applications;

8) that the candidate enjoys civil and political rights, and has not been the subject of a criminal conviction entailing disqualification from public office;

9) *for Italian citizens*: a declaration that he/she is registered on the electoral rolls with an indication of the municipality or the reasons for any non-registration on or cancellation from the electoral rolls;

10) that he/she has not been convicted of any criminal offence by a final judgment and that he/she is not currently undergoing criminal proceedings or administrative proceedings for the application of security or preventive measures, as well as previous criminal convictions entered in his/her criminal record, pursuant to Article 3 of Italian Presidential Decree No. 313 of 14 November 2002. If this is not the case, the convictions, proceedings and any criminal record must be indicated, stating the date of the order and the judicial authority that issued it or before which any criminal proceedings are pending;

11) *for Italian citizens only*: status with regard to military service;

12) that he/she has not been dismissed or discharged from their employment with a Public Administration for persistent inadequate performance or dismissed pursuant to current legislation;

13) that he/she has not been declared disqualified for having obtained the appointment or employment by producing false documents or documents affected by irremediable invalidity;

14) that he/she is not related by birth or marriage, up to and including the fourth degree, with a Professor belonging to the Faculty issuing the call or with the Rector, the Director General or a member of the Board of Directors of the University;

15) *for non-Italian citizens only*: that he/she has an adequate knowledge of the Italian language;

16) that he/she has not exceeded a total of twelve years, even if not continuous, including the period provided for in the contract referred to in this call for applications, as a research grant holder and as a researcher on a fixed-term contract in accordance with Articles 22 and 24 of Italian Law 240/2010, respectively, at Vita-Salute S. Raffaele University or at other Italian state, private or virtual Universities, or at the Institutions referred to in Article 22(1) of Italian Law 240/2010. Periods spent on maternity leave or leave for health reasons in accordance with the legislation in force do not count for the purposes of the duration of these relationships.

17) that he/she does not currently hold and has not previously held the position of full or associate professor or university researcher on an open-term contract;

18) as regards publications:

- A) for the overall scientific production:

i) total number of scientific publications and total impact factor;

ii) total number of citations and combinations of the previous parameters to valorise the impact of the scientific production (Hirsch index or similar) using scientific databases such as Scopus and Web of Science.

- B) for the scientific publications submitted,

i) impact factor **for each publication entered in the online procedure**;

ii) number of citations using scientific databases such as Scopus and Web of Science **for each publication entered in the online procedure**.

19) to have read and be familiar with this call for applications and the University Regulations for the recruitment of researchers on fixed-term contracts, pursuant to Article 24 of Italian Law no. 240/2010, issued by Rector's Decree no. 8767 of 15 February 2024.

The application must indicate the address which the candidate elects for the purposes of the selection, namely:

- any certified e-mail address (PEC) - **preferential address where indicated;**
- any postal address other the address of residence - **address used if the candidate does not have a certified e-mail address;**
- telephone number and e-mail address.

Any change in the address given must be promptly notified to the Rector (rettore@unisr.it).

The following must be attached to the application:

- 1) photocopy of a valid identity document and the tax code;
- 2) a curriculum vitae of their scientific and teaching activities as well as a curriculum vitae of their clinical care activities for those Scientific Disciplinary Sectors for which they are required. The qualifications, where indicated in the Curriculum, must be duly described (relevant period, institution at which the activity was carried out, description of the activity, etc.);
- 3) any qualifications deemed useful for the selection procedure and documentation concerning the act of recognition/equivalence of the PhD qualification. With reference to the provisions of Article 3 above, certificates or attestations in languages other than Italian, French, English, German and Spanish, as well as qualifications and certificates of foreign citizens who are not entitled to use the forms of simplified certification for bureaucratic purposes permitted by Presidential Decree No. 445/2000, must be attached. Please note that the qualifications, where indicated in the Curriculum, must be duly described (relevant period, institution at which the activity was carried out, description of the activity, etc.);
- 4) publications submitted in accordance with Article 5 below.

The University Administration does not accept responsibility in the event that the addressee cannot be reached and in the event of communications not delivered due to the provision of incorrect address information by the applicant or failure by the applicant to give notification of a change of address with respect to that indicated in the application or failure to do so in good time. Moreover, the University Administration does not accept responsibility for any failure to deliver or late delivery of communications relating to the selection procedure for reasons not attributable to the Administration itself, but to postal or telegraphic problems, the fault of third parties, unforeseeable circumstances or force majeure.

ART. 5

Publications

Publications, including the PhD thesis that candidates wish to submit for the selection procedure must be submitted electronically in PDF format, using only the dedicated online application available at:

Publications considered useful for the selection procedure must be submitted in compliance with the **maximum number of publications** provided for in the annex to the call for applications relating to the selection procedure in which the candidate intends to participate.

For **proven and justified** technical reasons beyond the candidate's control, publications that cannot be uploaded to the above-mentioned online application must be listed in a specific list to be entered in the online platform and uploaded on a medium (CD or DVD or USB device) exclusively in PDF format or sent in hard copy. The paper or printed publications must be delivered, no later than the deadline established in this call for applications, either by hand, to the Department as indicated in article 3 of this call for applications, as indicated therein, or by registered mail with return receipt, addressed to the Rector of Vita-Salute S. Raffaele University, Via Olgettina 58, 20132 Milan; the postmark and date of the accepting post office shall be valid for deadline purposes.

On the envelope containing the storage device or publications in paper format, the candidate must clearly state his/her first name and surname and state the selection in which he/she intends to participate, specifying the Faculty, the application scientific-disciplinary group and the scientific disciplinary sector. Storage devices must be labelled with the candidate's first and last name and date of birth.

Without prejudice to the above-mentioned case of proven technical impossibility, please note that pursuant to Article 3 of this call for applications, the Recruitment Committee will assess the publications uploaded to the PICA platform. Please note that, if the maximum number of publications is exceeded, the Recruitment Committee will assess them in the order in which they are listed in the application, until the limit set is reached.

For the application sectors in which their use is established at international level, candidates must include in their application form the bibliometric indicators relating both to their own scientific production and to the publications submitted by the candidate for evaluation, using scientific databases as better specified in Article 4 of this call for applications.

It should be noted that, pursuant to Ministerial Decree 243/2011, the PhD thesis is to be considered a publication, and therefore, if the candidate intends to submit it, he/she must count it in the maximum number of publications provided for in the annex to the call for applications relating to the selection procedure in which he/she intends to participate.

Only publications or texts accepted for publication in accordance with the regulations in force, as well as essays included in collective works and articles published in journals in paper or digital format, with the exclusion of internal notes or departmental reports are considered assessable for the purposes of this selection procedure, the PhD thesis or thesis of equivalent qualifications are taken into consideration also in the absence of these conditions.

Texts or articles accepted for publication must be submitted with the publisher's acceptance document by the call for applications deadline.

In the case of publications printed abroad, the date and place of publication or alternatively the ISBN or ISSN code or other equivalent must be indicated.

For publications printed in Italy prior to 1 September 2006, the obligations set forth in Article 1 of Legislative Decree No. 660 of 31 August 1945, and subsequently those set forth in Italian Law No. 106 of 15 April 2004 and Italian Presidential Decree No. 252 of 3 May 2006 must be fulfilled.

Fulfilment of these obligations must be certified by appropriate documentation attached to the application attesting to the deposition, or by a declaration by the candidate in lieu of affidavit, pursuant to Article 47 of Italian Presidential Decree No. 445/2000. Publications must be presented in the original language and, if different from those indicated below, translated into one of the following languages: Italian, Latin, French, English, German and Spanish. Translated texts may be submitted as typewritten copies together with the printed text in the original language.



ART. 6

Exclusion from the selection

Candidates are conditionally admitted to the selection. The Rector may at any time, by reasoned Decree, order exclusion on the grounds of failure to meet the participation requirements, or in any of the cases provided for above, including failure to produce the act of recognition or equivalence.

ART. 7

Constitution of the Recruitment Committees

The Committees are identified in accordance with the provisions of Article 11 of the University Regulations for the recruitment of researchers on fixed-term contracts, pursuant to Article 24 of Italian Law no. 240/2010, issued by Rector's Decree no. 8767 of 15 February 2024.

The Committees are appointed by Rector's Decree and published on the University website. The rules concerning incompatibility and conflict of interest apply to the composition of the Committees.

The thirty-day period in which candidates may raise objections concerning the Committee members begins on the date of publication on the University's website; if all the candidates expressly declare that the Recruitment Committee is not affected by any cause for objection, this period may end prematurely.

ART. 8

Tasks of Recruitment Committees and examinations

The recruitment of fixed-term researchers is carried out following selection procedures that ensure the comparative assessment of the candidates and the publicity of the documentation.

The criteria and procedures for the evaluation of the candidates are established by the Committees, without them having had access to the documentation submitted by the candidates.

The names of the candidates may also be published on the University website once the Recruitment Committee has defined and published the assessment criteria.

Recruitment is carried out, once the Recruitment Committee has verified the admissibility of the applications, by means of a preliminary assessment of the candidates with a reasoned analytical appraisal of their qualifications, curriculum and scientific production, including their PhD thesis, in accordance with the criteria and parameters established by Italian Ministerial Decree no. 243 of 25 May 2011.

Following the preliminary assessment, the comparatively most deserving candidates, representing between 10 and 20 percent of the total number of candidates, and in any case not less than six, are admitted to a public interview with the Committee on their qualifications and scientific production, which may also take the form of a seminar open to the public.

All candidates shall be admitted to the interview stage if six or fewer applications are received.

During the interview, candidates will also have to take an oral examination aimed at demonstrating their adequate knowledge of the **foreign language**, as set out in the annex to the call for applications of the selection procedure in which they intend to participate.

The interview and oral examination session is public.

Committee) in/with which the discussion and exam will take place. For electronic connections, the workstation from which candidates will have the interview and oral examination must be equipped with a webcam – which is essential for identifying the candidate – a microphone and headphones and/or speakers.

ART. 9

Verification of documentation compliance and call proposal
