Having seen Ministerial Decree no. 440 of 13 February 2024, "Definition of the list of particularly impoverished states for the 2024/2025 academic year";

Having seen Law no. 241 of 7 August 1990, as amended "New regulations governing administrative procedures and right of access to administrative documents";

Having seen the Regulations governing the employment of students in University services approved by Rector's Decree no. 7603 of 18 November 2022;

Having seen the Executive Board Resolution of 29 April 2024;

Having seen the competition call for the awarding of students' collaborations a.y. 2024/2025 of 8 May 2024, prot. UniSR/CD/450/AFDAE/LP/rb;

The final ranking that indicates the selected students will be published once the aptitude interviews have been completed.
