THE RECTOR

Having seen the Charter of Vita-Salute San Raffaele University, approved with the Decree issued by the Italian Minister for Universities, Scientific Research and Technology on 2 August 1996, as amended.

Having seen Italian Decree Law no. 6 of 23 February 2020, converted, with amendments, by Law no. 13 of 5 March 2020, containing "Urgent measures to contain and manage the Covid-19 epidemic emergency".

Having noted the general and specific measures to contain infection in force nationwide and the provisions made by Vita-Salute San Raffaele University implementing the protocols for management of the pandemic.

DECREES

Art. 1 - Lectures, course examinations and final examinations for the award of academic qualifications

Lectures, course examinations and final examinations for the award of academic qualifications for all undergraduate and postgraduate Courses run by Vita-Salute San Raffaele University will continue to be held in in-person mode, in accordance with the calendars published by the Offices of the respective Courses.

Students in self-isolation, vulnerable students or students exempt from vaccination on the basis of specific medical certification issued on the criteria set by the Italian Ministry of Health, and students resident in countries where travel restrictions are in place, will also be permitted to attend these activities remotely.

Students in one of the above situations must send an exemption request to the Presidents of their respective Courses.

Art 2 - Internships

Internships will continue to take place normally with physical attendance on site and will be organised in accordance with the decisions of the Host Organisations.

Art. 3 - Laboratory teaching activities

Laboratory teaching activities will continue to take place normally, and will be organised in accordance with the decisions of the Host Organisations and with the regulations in force to contain infection within the University.

Art. 4 - Practical activities for medical residents

Practical activities for medical residents will continue as normal.

Art. 5 - Postgraduate internship for admission to the State Examination for qualification to practise as a psychologist

Postgraduate internships for admission to the State Examination for qualification to practise as a psychologist will continue to take place normally, and will be organised in accordance with the decisions of the Host Organisations, with a schedule agreed with the Dean of the Psychology Faculty.

Art. 6 - Research activities

The research activities of full professors, contract researchers, research grant holders, associates and PhD students will continue normally in agreement with the heads of the respective laboratories and in compliance with the instructions of the Host Organisations.

Art. 7 - Administrative technical activities

The administrative technical activities of University staff will take place on an "in person" basis, while all services for which this mode is feasible may continue to be carried out remotely, in agreement with the respective Managers and in accordance with the organisational guidelines provided by the University.

Front office services will be provided in "in person" mode and will also continue remotely, in accordance with the organisational guidelines provided by the University.

Art. 8 - Library, IT classrooms and study rooms

The library, IT classrooms and study rooms will be open.

Art. 9 - Travel and missions

Teaching staff and researchers, technical and administrative staff, associates and those enrolled on all undergraduate and postgraduate Courses are advised to cut down on travel, departures and missions to destinations with a high infection risk, in compliance with the requirements and restrictions enforced in the individual countries concerned.

Art. 10 - Incoming exchange students

Foreign students hosted by the University within the Erasmus+ programme or other international exchange programmes are permitted to join the University as respectively planned by the individual Courses and Faculties in compliance with the provisions of central and regional government.

Art. 11 - Collegiate body meetings

Meetings of the University's collegiate bodies may also take place remotely.

Art. 12 - Electoral procedures for the renewal of collegiate bodies and elected posts

The University's electoral procedures may also take place remotely.

Art. 13 - Selection procedures for the recruitment of Professors and Researchers

In the selection procedures for the recruitment of full and associate professors, for posts published before the expiry date of this Rector's Decree, Selection Boards may also use video conferencing systems for all phases of the procedure.

In the procedures for the recruitment of contract researchers, for posts published before the expiry date of this Rector's Decree, Selection Boards may also use video conferencing systems for their discussions and when interviewing candidates.

Art. 14 - University Halls of Residence

University Halls of Residence will remain open.

Art. 15 - Compulsory vaccination and COVID-19 certification (Covid Pass - "Green Pass")

Permanent teaching staff, contract researchers and technical and administrative staff are subject to compulsory vaccination against infection with Covid-19.

In order to access the University's facilities at the Via Olgettina and San Raffaele Turro sites, the aforesaid must hold Super Covid Pass - "Green Pass Rafforzato" Covid-19 certification; to access the University's other facilities, they must hold Basic Covid Pass - "Green Pass Base" Covid-19 certification, unless subject to the tighter restrictions set out in the points below.

In order to access the University's facilities, students registered on all undergraduate and postgraduate courses of Vita-Salute San Raffaele University, including students involved in international exchange projects, contract teaching staff, Visiting Professors, Visiting Scholars, research grant holders, scholarship holders, contract researchers, personnel employed at the University under external contracts, candidates and visitors must hold Basic Covid Pass - "Green Pass Base" Covid-19 certification, unless subject to the tighter restrictions set out in the points below.

With regard to access to the premises of Host Organisations, the aforesaid must follow the rules established by the said Organisations (including the OSR perimeter).

Undergraduates performing assessed practical internships for state registration as a health professional are subject to compulsory vaccination against infection with Covid-19.

Access to the University Halls of Residence is only granted to persons who hold Super Covid Pass - "Green Pass Rafforzato" Covid-19 certification.

Access to the library for any purposes other than the collection and return of books is only granted to Super Covid Pass - "Green Pass Rafforzato" Covid-19 certification holders.

Super Covid Pass - "Green Pass Rafforzato" Covid-19 certification is required for attendance at conferences and congresses.

All persons referred to in this article must show their Covid Pass on the request of the staff designated to checking duties. Spot checks will be performed on students in accordance with the procedures defined by the University.

In accordance with current law, anyone not holding or refusing to show the appropriate Covid-19 pass will be accompanied off the University premises at once, with notification of the relevant authorities.

The above provisions do not apply to people who hold exemption from vaccination on the basis of specific medical certification issued on the criteria defined by the Italian Ministry of Health.

Art. 16 - General provisions

The above activities will take place in compliance with all general and specific health and hygiene measures envisaged by the current regulations and the protocols issued by Vita-Salute San Raffaele University to contain Covid-19 infection, and all measures regulating international travel and travel within and between Regions in force at any time will also be complied with.

The provisions of this Decree may be subject to further restrictions or changes in response to the evolution of the epidemic and in accordance with specific provisions of central or regional government authorities.


Art. 17 - Validity
