## **CHANCELLOR'S DECREE N. 7022 ESTABLISHING A SECOND TEST SESSION RESERVED FOR NON-EUROPEAN CITIZENS RESIDING ABROAD FOR ADMISSION TO THE INTERNATIONAL MEDICAL DOCTOR PROGRAM**

**AY 2021/2022**

**In compliance with the Italian Ministerial Decrees currently in force and in accordance with Art. 5.1 of the Chancellor's Decree n. 6885 dated January 20, 2021 regulating the Competition, a second test session has been established for non-European citizens residing abroad for admission to the 2021/2022 academic year.**

### **Art. 1 – new admission test session for the 2021/2022 academic year**

The second admission test session reserved for NON-European citizens residing abroad to access **the International Medical Doctor program** will take place on **July 22<sup>nd</sup>, 2021**.

### **Art. 2 – number of places available**

Considering the remaining available places after the admission test of March 24<sup>th</sup>, 2021, the number of available places for the second test session reserved for NON-European citizens residing abroad is: **23**.

Further places may become available as a consequence of possible withdrawals of previously admitted candidates, who took the admission test on March 24<sup>th</sup>, 2021.

**May 10<sup>th</sup>, 2021** at noon (CET) and closes on **July 15<sup>th</sup>, 2021** at noon (CET).

Candidates may register for the test according to the procedure indicated in the Admission Regulations – Chancellor’s Decree n. 6885 dated January 20<sup>th</sup>, 2021.

#### **Art. 4 – admission test modality**

The admission test will be delivered with an **online proctoring system**. Technical requirements and all necessary information will be sent to all candidates via e-mail within 3 days prior to the test date.

#### **Art. 5 – confirming the assigned place and enrolment**

Admitted Candidates will have to proceed with the online enrolment through the university portal within the deadlines and according to the instructions that will be published on the website [www.unisr.it](http://www.unisr.it).

#### **Art. 7 – miscellaneous**
